

BUS RULES

1. Students must remain in their seats, facing forward at all times while on the bus.
2. All students will have an assigned seat.
3. Students must talk quietly and respectfully while on the bus.
4. You may not yell from the back of the bus to the front of the bus or vice versa.
5. Keep your whole body inside the bus.
6. Do not throw anything from the bus.
7. No pushing, shoving, fighting, shouting, or inappropriate language.
8. No eating, drinking, gum chewing, smoking, spitting, destruction of property, or possession of harmful objects.
9. Do not bother other students or their belongings.
10. Get on and off only at a designated LEO stop.
11. If a student needs to use a different stop in the afternoon, the student's parent must send a note to the school office. The office will issue a bus permit to the student. If the student does not have a permit, the student will not be allowed to use the stop.
